



Following are notes taken from the 24 JUN FFXBEOC teleconference. These notes are not all encompassing but will provide basic insight to the discussions.

- (RISE) The Fairfax small business loan application program received close to 7K applications and a decision should be made quickly.
- Fairfax Conducting a 2 times 4 times a week local testing in church parking lots and schools and community centers. People can walk to it.
 - Every event brings more refinement of data
 - Continue events throughout summer
 - Immunization events to get kids ready for school for fall
 - Higher number who have fallen behind on their immunizations
 - 400 workforces of tracers. 50% of Health department staff. Training by John Hopkins 5-day training course and then a week of onboarding contact team.
 - Will be mostly contract with some staff.
 - A lot of case/contact tracing to do further investigation to do referrals human services for the community.
 - Phase 3 coming soon maybe next Monday
 - Going by the data to make recommendations to Governor
 - Panelist on webinars to help business order to open/expanding their operations.
 - Working on webinar for viewed on demand
 - Dispel CDC interpretation guidance
- EOC
 - Continuing with operations
 - Accepting donations of PPE and household items at warehouse
 - Volunteer groups helping food distribution and running errands for the vulnerable
 - Helping and have openings for warehouse through a volunteer community
 - Concerned about recovery and accessing the grant money and to ensure the information needed gets out.
 - RISE is closed
 - Request that we tap our networks and understanding the phase 3 doesn't mean not being safe.
 - Sending message kit to Craig for the community to stay on message.
 - Looking at slowing down their operation down
 - Will keep the logistics piece going at the EOC
 - Plans and Human Services will rotate back to every other week office/work
 - Temporary shelter (6 hotels):
 - Isolating if living conditions are crowded and can't isolate
 - How to go back once isolation is over

 - Slight improvement in business that were completely shut down and are now opening up.
 - Businesses are struggling still and navigate for revenue.
 - Most of the none-branch officers will not return soon

 - Response: Maybe we need a best practice.
 - Response: Need something like a coach/counselor that help the company get back up digitally/physically.
 - Response: Perhaps the Chambers of Commerce needs to be the advocate for small business.
 - Response: As a BEOC we should reach out to the different small business communities.
 - Maybe some type of digital media to explain why to join BEOC
- Excel (Deb):

 - Many businesses are restarting and refocusing on staffing
 - The DHS national exercise has been rescheduled till August
 - Would like FFXBEOC prepped in order to participate at the national level
